## QuickStix Resilient Sheet Flooring Warranty

<b>Features Warranted</b>	Mannington Commercial QuickStix resilient sheet is backed by a limited warranty for bond and manufacturing defects. The duration of the Mannington Commercial QuickStix Resilient Sheet Flooring Warranty varies per style and matches the product warranty. Mannington Commercial's QuickStix Resilient Sheet Flooring Warranty is for its original installation site(s), subject to the exclusions, conditions and limitations described below.
<b>Exceptions and Limitations</b>	<ol style="list-style-type: none"><li>1. Mannington Commercial QuickStix resilient sheet flooring is applied as specified in Mannington Commercial's most current installation and maintenance instructions and guidelines and any other technical information available in Mannington Commercial's current technical literature and/or in manningtoncommercial.com. These instructions describe in detail the substrate condition upon which Mannington Commercial QuickStix resilient sheet flooring is applied. Those conditions must be appropriate at the time of installation and for the entire term of the Warranty. Reference the current ASTM F710, "Standard Practice for Preparing Concrete Floors to Receive Resilient Flooring," and ASTM F301 for additional details.</li><li>2. At all times, installation environment does not exceed a Relative Humidity (RH%) of 99% when tested in accordance with the most current ASTM F2170 and ASTM F710. For RH levels of 95% and below, apply one coat of approved primer. For RH levels of 95% to 99%, apply a second coat of approved primer. <b>Note:</b> For renovation projects exceeding 95% RH, please contact Mannington Commercial Technical Services at 800.241.2262 ext. 3 for additional direction.</li><li>3. If the substrate fails to meet the moisture and pH requirements as stated above, at any time during the Warranty period, the Warranty shall be void.</li><li>4. If approved primer was not used before Mannington Commercial QuickStix resilient sheet flooring installation, the Warranty shall be void.</li><li>5. Labor for material installed with obvious defects is not covered by this Warranty.</li><li>6. Problems due to moisture, mildew, alkaline substances or hydrostatic pressure in the subfloor are not covered by this Warranty.</li><li>7. Labor costs for repair or replacement of material which was not originally professionally installed is not covered by this Warranty.</li><li>8. Customers must keep moisture testing data and substrate photos on file and provide copies to Mannington Commercial upon Mannington Commercial's request.</li><li>9. For Mannington Commercial QuickStix resilient sheet flooring that is applied over existing hard surface flooring, if bond failure of the existing flooring to the substrate occurs and/or bond failure of Mannington Commercial QuickStix resilient sheet flooring to the surface of the existing flooring occurs, due to contamination or inadequate surface preparation, the Warranty shall be void.</li></ol>

**Remedies**

Mannington Commercial, at its option, may designate a representative to inspect the floor and/or have it tested by an independent testing firm. If the inspection or independent testing reveal that Mannington Commercial QuickStix resilient sheet flooring has not performed as stated in this Warranty, if installed by a professional flooring installer/contractor, Mannington Commercial will, at its option: (i) repair without charge the affected flooring to conform to the warranty; or (ii) replace the affected flooring without charge, with flooring of equal value and/or quality. Mannington Commercial will also pay for reasonable labor costs per the conditions stated above. Mannington Commercial will not pay for the removal or replacement of cabinets, appliances, or other fixtures. Replacement floors are warranted only for the remaining time of the original warranty and are not warranted to match samples or marketing materials (i.e. photographs, website, etc.) or match in color, dye lot, and gloss with your existing floor. All other costs, including the cost of removing equipment, furnishings, partitions, or anything else installed or placed over the carpet, are the responsibility of the end-user.

**Additional  
Limitations**

This Warranty only covers the original end-user of the Mannington Commercial QuickStix resilient sheet flooring at its original installation site(s) and is not transferable.
